If damage occurs in the interior of the vehicle, the lessee responsible for the damage incurred has to pay compensation for damage in the amount of the price of the damaged car part and service work. If the amount for repair of any damage to the vehicle exceeds the amount of 3,320 €, the lessee will be charged co-participation of 5% of the damage caused.

The list of the most common vehicle damages is not definitive one and TMK Solutions s.r.o. reserves the right to change the above mentioned rates. The listed rates represent the financial value which is to expend to eliminate the damage that has been caused to the vehicle. Likewise, mentioned rates represent financial loss in the value of the vehicle caused by the concrete damage/devaluation that should be compensated to TMK Solutions s.r.o. even if the damage on the vehicle will not be repaired.

TMK Solutions s.r.o. reserves the right to repair the vehicle within time limit in which the length of repair time is reduced in the most effective way so that the vehicle is out of operation as short time as possible. The customer has the right to request repair of the vehicle as soon as the damage has been quantified. In this case, the customer is obliged to pay a charge for downtime amounting 50% of the standard rental/lease value for the entire length of the service interval, i.e. time when the vehicle is out of running due to repairing the damage in question.
